 - reviewing, monitoring, removing, replacing trees. Rainbow Tree is way behind on projects because of storm damage.
- <u>Hospitality/Welcoming Committee</u>: Premier sends a welcome packet. Discussion regarding the need to welcome new families to the neighborhood within first 30 days. Ask for volunteers at the Annual Meeting and in the Newsletter. There is money in our budget for a card / basket etc.
- Results from National Night Out: Weather was perfect, but only 24 attending compared to 38 the previous year. Fire Chief, four Police Officers and John Bermel City Council Member stopped by. Many owners came from different areas in the Association. We will continue to request a Council Member and/or Police Officer as a guest. Twenty-four pounds of food and \$90 in cash brought to food shelf.

V. Business From the Floor:

Green & Black: Homeowner realizes it is difficult to get quality workers. Cost and timing of trees appear to be an ongoing issue. She is concerned with increasing dues.

The following were pointed to Jeremy during the walkthrough with Green & Black. They did communicate to the mowers and trimming, so we should be expecting better results.

- Grass Mowing Crews Driving on top of the edging and landscape rock areas which damages the black vinyl edging, causing breaks in the joints and other damage to the vinyl.
- Grass Mowing Crews Driving on the rock landscape rock which kicks out dozens of rocks into the grassy areas all over the yards which causes hazards to mower, and anyone if in the area if mower shoots one out.
- Down Spouts that land on the vinyl edging keep getting run into by the Wheels of the Mower Crews who are driving right on the rock/vinyl edging.
